State House Districts Proposed Plan PLANH2109

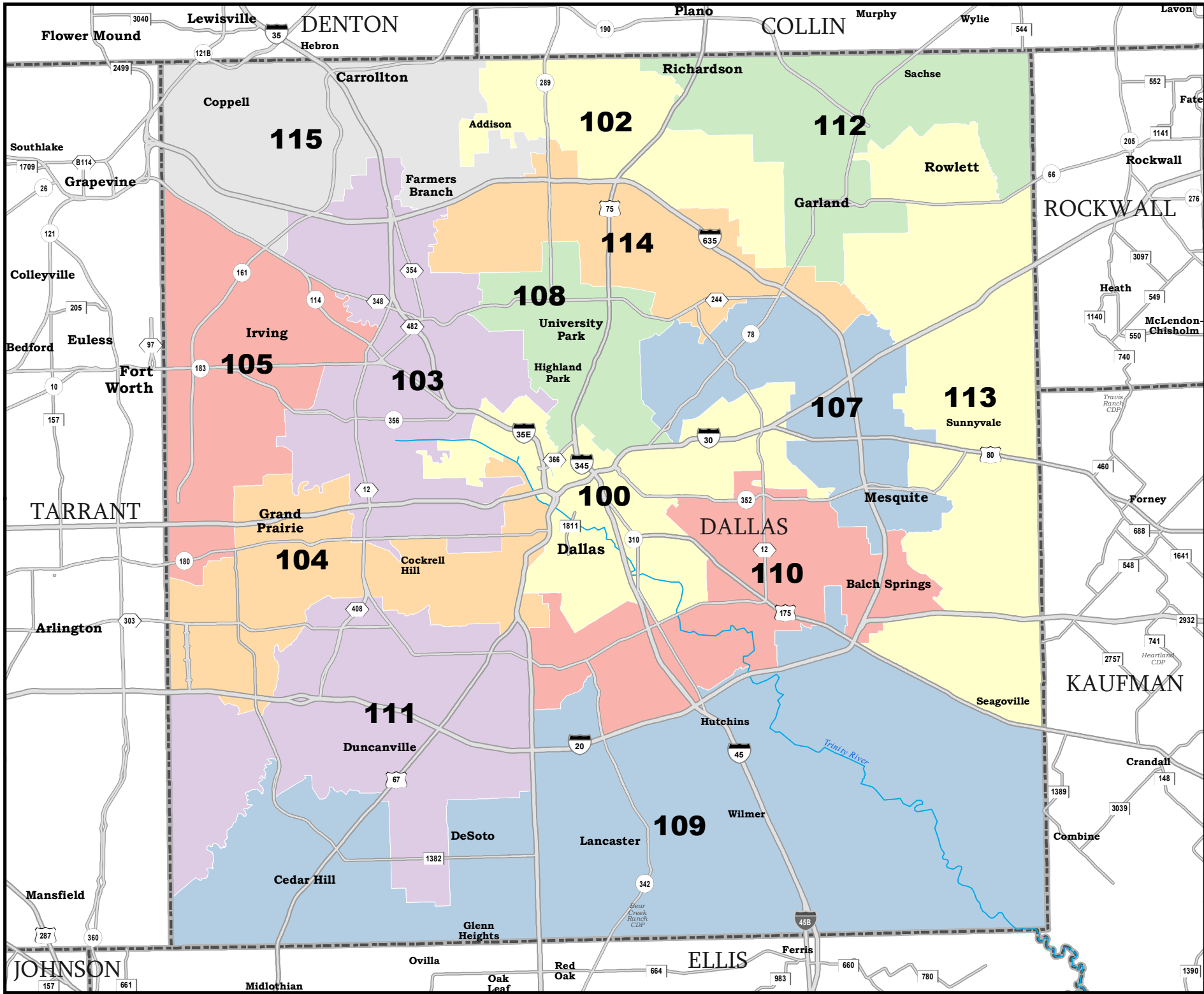
