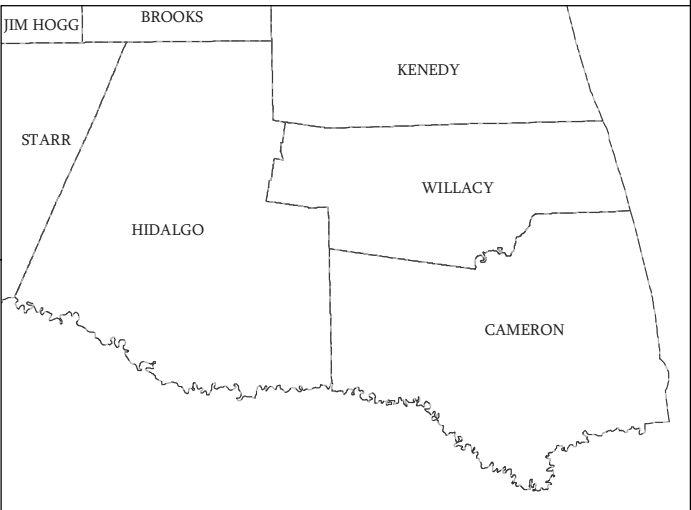

State House Districts Proposed Plan PLANH2110

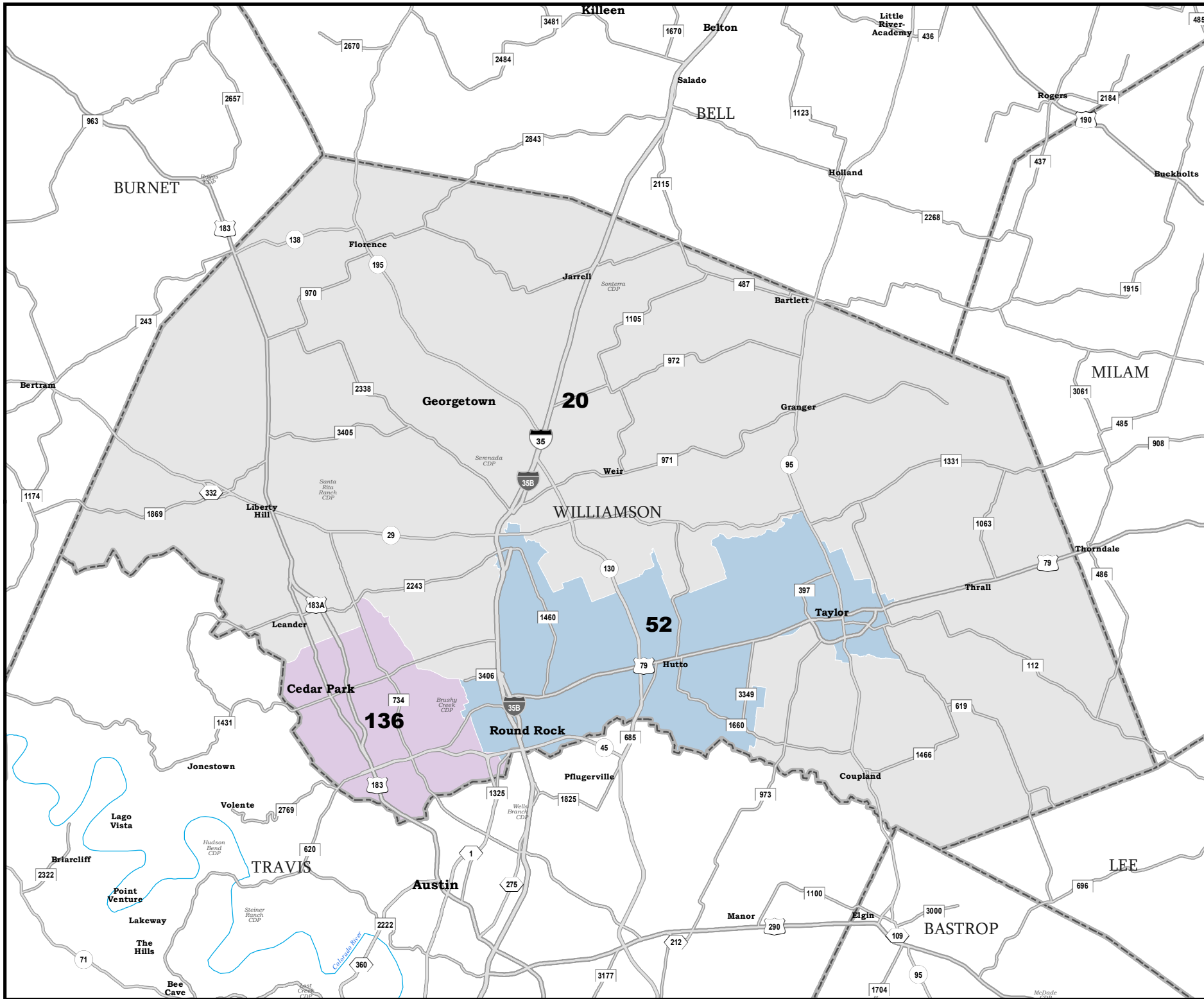
