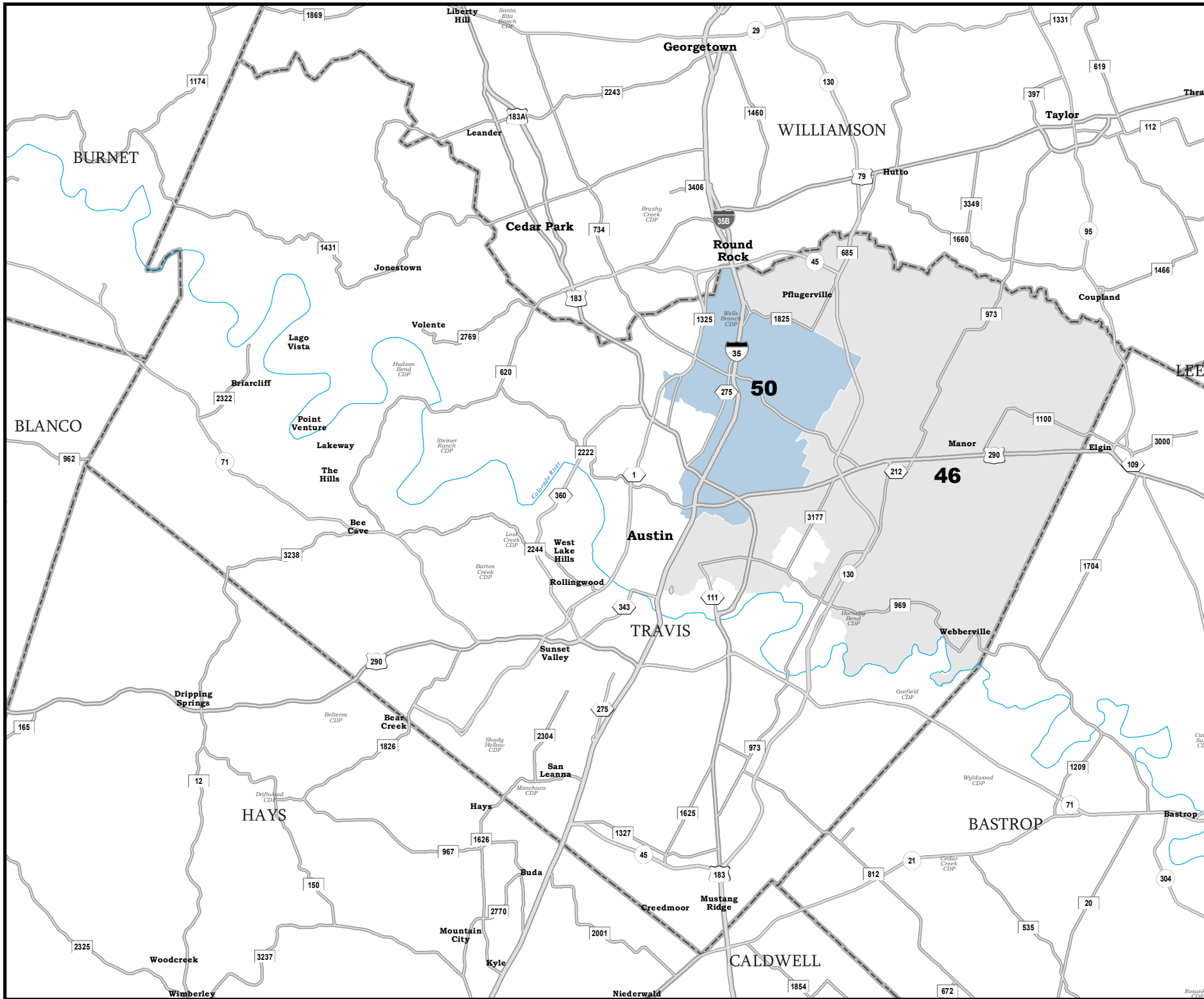
State House Districts Proposed Plan PLANH2139

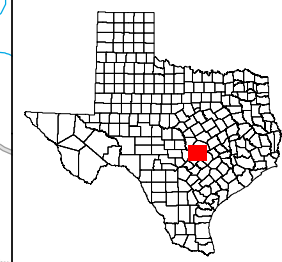
