State Board of Education Districts Proposed Plan PLANE2130



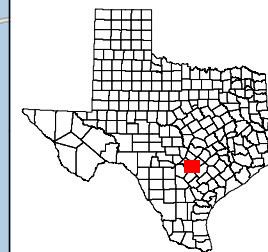

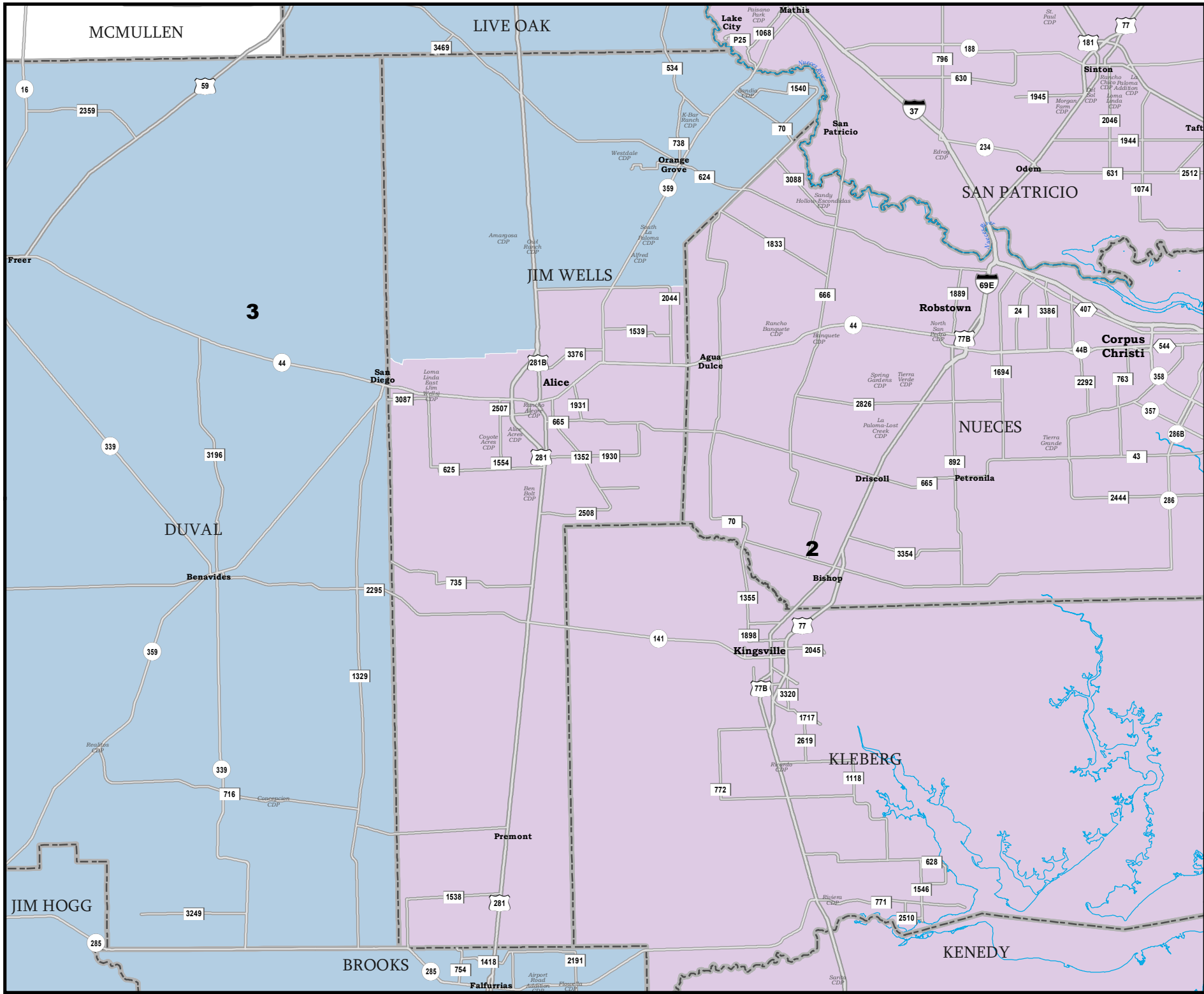


HARRIS COUNTY

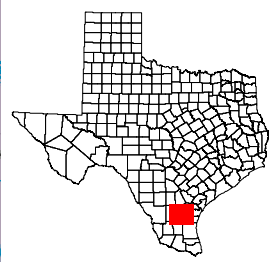
