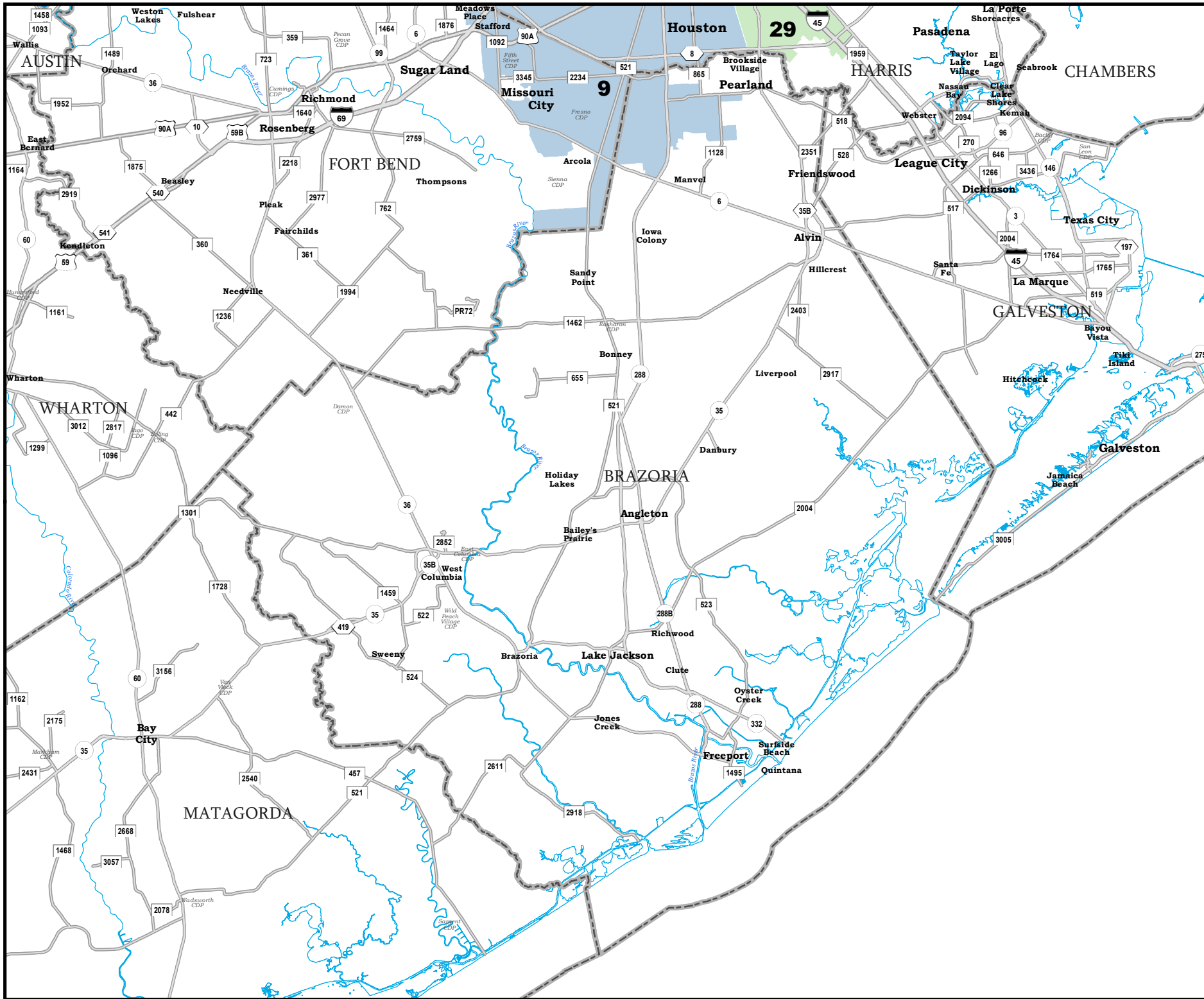

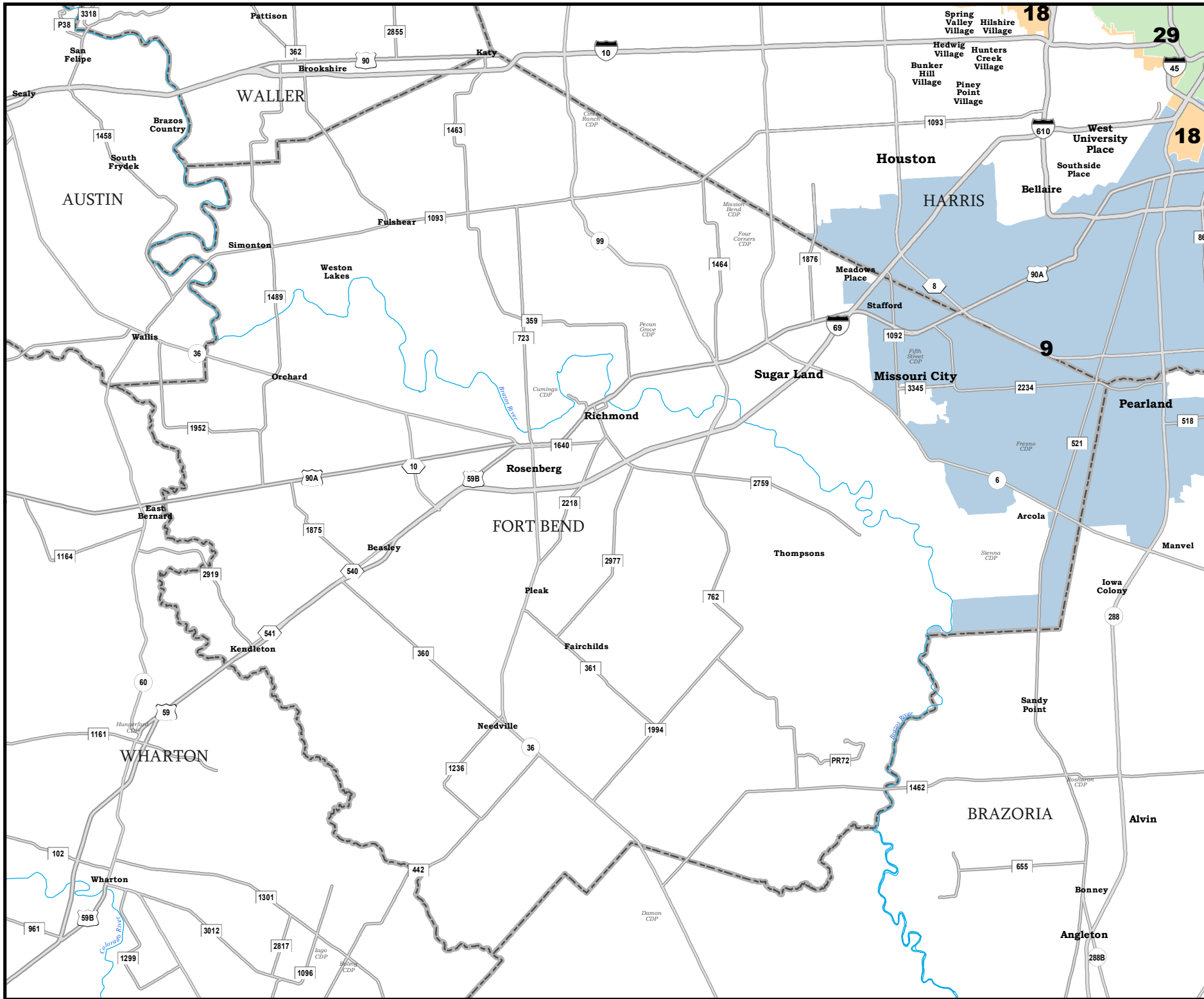

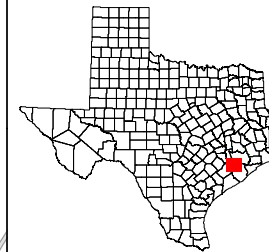


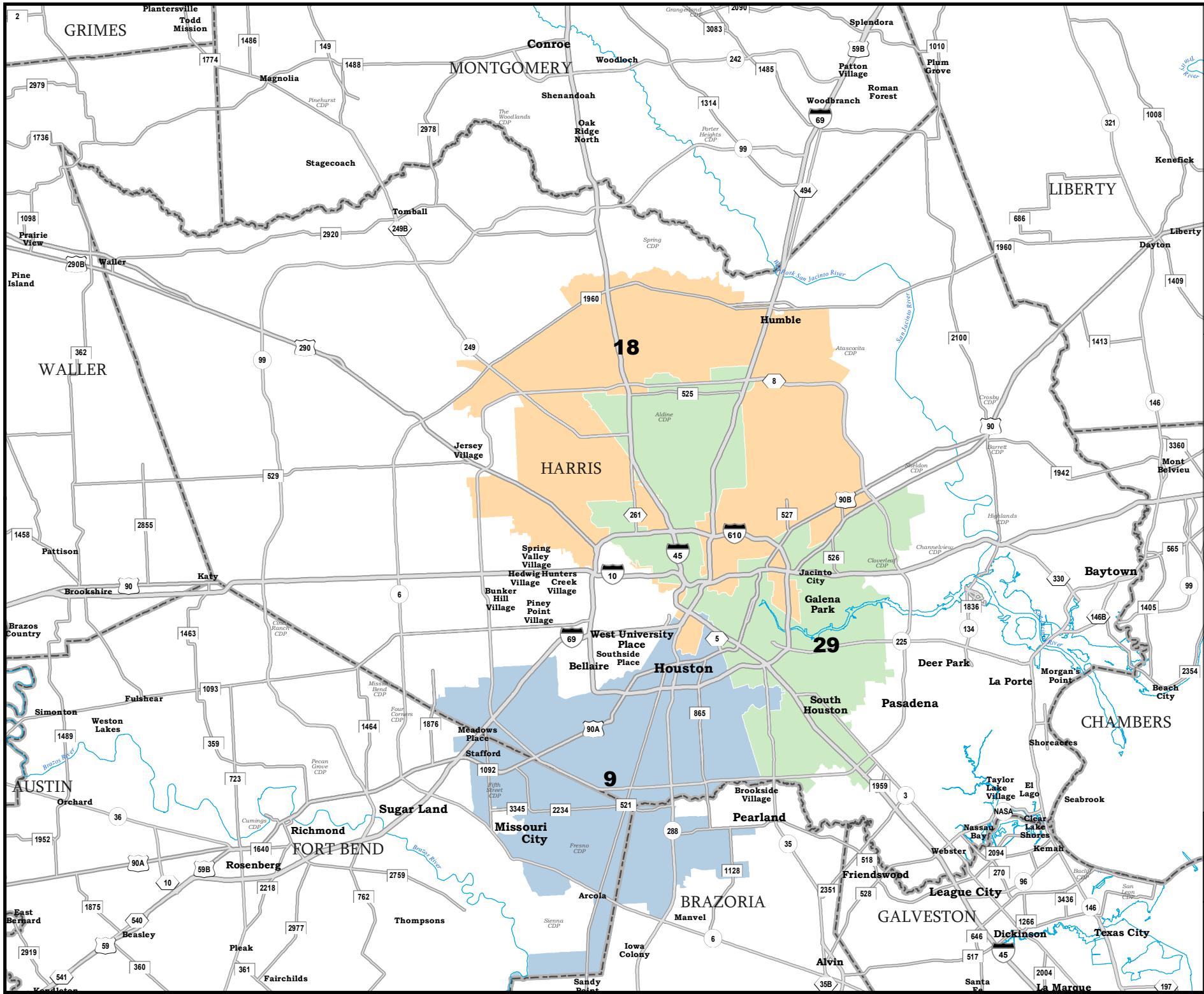


FORT BEND COUNTY

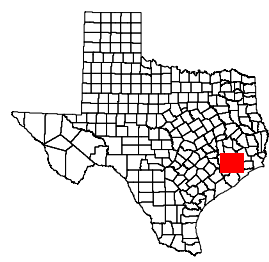




HARRIS COUNTY
