State House Districts Proposed Plan PLANH2196



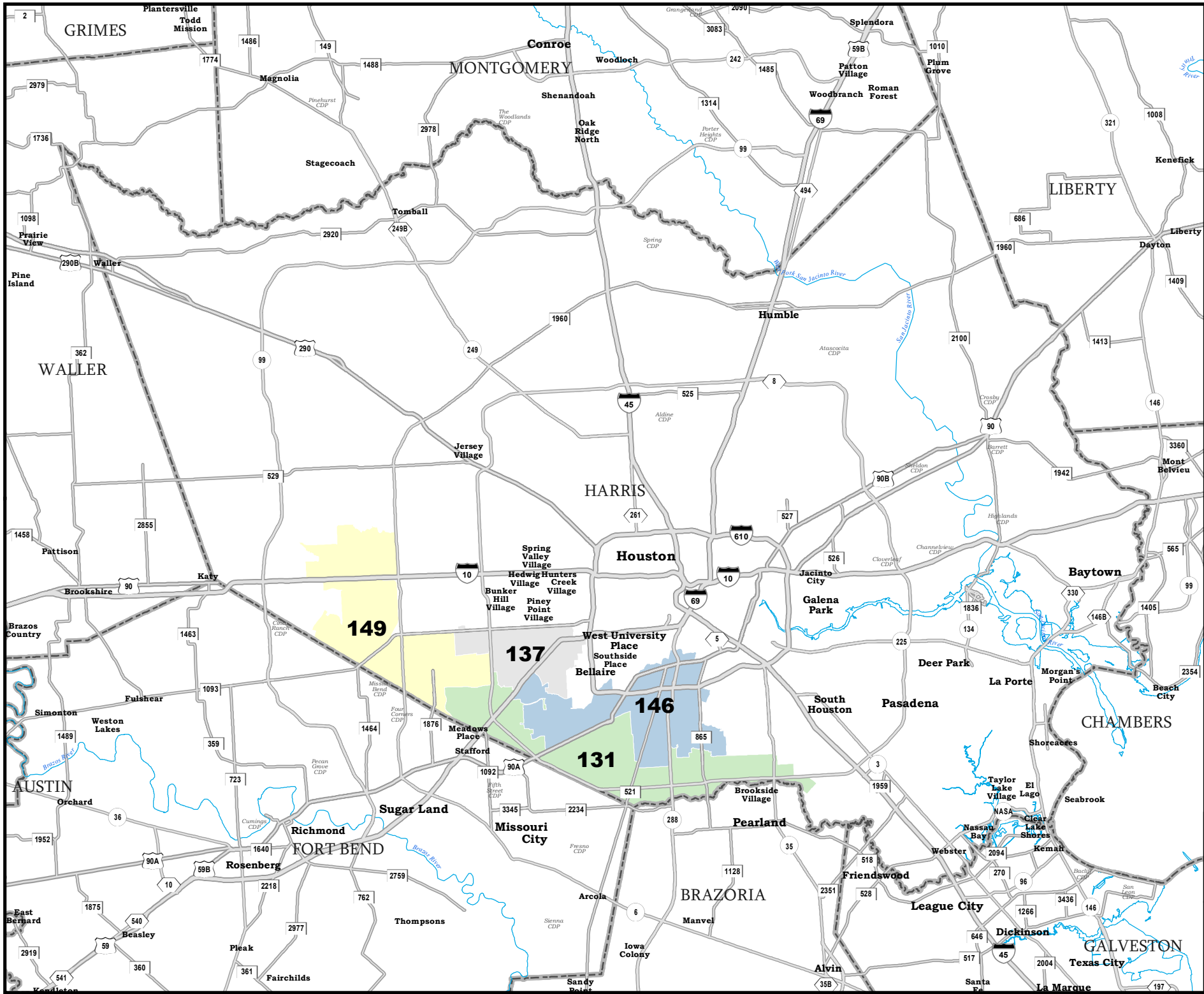

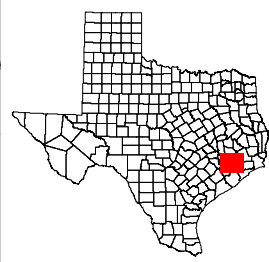
